WHAT IS THE LCDA CRUISE PERFORMANCE HOLIDAY?

In 2027, LCDA dancers and their families are invited to join us on a 4-night cruise with Dance Cruise Co, where our dancers will have the opportunity to perform onboard as part of a special LCDA Cruise Concert Experience.

This is designed to feel like:

- ★ An onboard concert performance & workshop!
- ★ A family holiday
- ★ Memories to last a lifetime!

This experience is about confidence, fun, teamwork and creating beautiful memories with your dancer & your family!

WHO CAN ATTEND?

- ★ Open to La Crème dancers (Dancers in our beginner classes + above, dancers turning 5+ years) (La Creme Minis & La Creme Kids classes welcome to attend however cannot perform on stage)
- ★ Siblings, grandparents and extended family and friends are welcome to cruise and watch (minimum age to travel is 6 months old)
- ★ This is a family holiday with a performance opportunity built in!

ONBOARD PERFORMANCE DETAILS

Dancers will perform in a concert showcase onboard the ship in the GRAND THEATRE. The performance will last for approximately one hour.

All dancers will perform in an opening routine & finale routine, group and other routines will be confirmed once we know dancers attending. (may include concert routines, eisteddfod routines, which will be decided by LCDA based on dancers attending)

This is not a ticketed event- audience will be cruise passengers and families onboard
*LCDA staff will supervise dancers during rehearsal and performance times



ONBOARD WORKSHOP DETAILS

All dancers have the opportunity of attending a dance workshop onboard.

Younger dancers will have their workshop (in the form of a class) with Miss Bec & LCDA staff so dancers have a familiar face. Older dancers will take workshops with cruise ship professional performers!

Workshop details will be communicated after bookings are received.



PARENT SUPERVISION

This is a family holiday. LCDA staff will supervise dancers during:

- Rehearsals
- Performances
- Workshop

At all other times:

👉 Parents/guardians are responsible for their children onboard the ship.

Dancers will learn & practice routines during Term 4 2026 & January 2027.

- Costumes TBA (reusing concert costumes where possible), maximum cost per costume is \$100 & LCDA will source 2nd hand costumes where possible.
- Final run-through may occur onboard (time TBA)

As the performance will be built around our dancers who register, rehearsal timetable will be sent after registrations close.

*no aerial routines - all will be dance based.

♥ LCDA performers to also purchase the performers package separately.

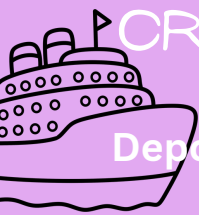

This includes all food, entertainment, accommodation, private party including cocktail/mocktail hour, Q & A with a cast member & momento group photo!

*LCDA must have at least 50 people traveling to be able to proceed (we expect to reach this).

*Limited places available, bookings will be closed off once we reach the limit.



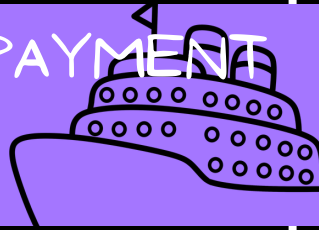
CRUISE DEPOSIT

Q: What if we want to cruise but not perform?

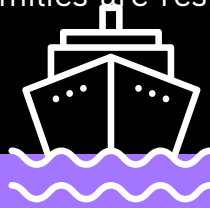
A: You're welcome to cruise and support without your dancer performing!
